This IHG Vendor Code of Conduct sets out the requirements, principles and practices that IHG has adopted to promote ethical conduct in the workplace, safe working conditions in the supply chain, treatment of persons with respect and dignity, and environmentally responsible practices. These are the minimum standards under which IHG vendors are expected to operate, and IHG encourages vendors to exceed the requirements set out below.

Vendor declares herewith:

Compliance with Laws and Regulations

- to comply with the laws of the applicable countries in which it operates as well as international laws related to the conduct of business.

Labour and Human Rights

- to support the protection of human rights, particularly those of its employees, the parties with whom it conducts business and the communities where it operates
- to respect its employees' rights to voluntary freedom of association under the law
- to provide a safe and healthy working environment
- to not support forced and compulsory labour or the exploitation of children
- to support the elimination of employment discrimination and harassment, and promote diversity in the workplace
- to provide employees with remuneration and tools for growing their careers, and take their wellbeing into consideration.

Environmental Protection

- to implement sound environmental practices in the design, development and operation of its business and provide the training and resources required to implement such practices
- to encourage the development and integration of sustainable technologies and to endeavour to reduce the use of energy and water, and re-use and recycle the resources consumed by its business wherever practical
- to engage its customers, colleagues, partners, suppliers and contractors in its efforts to protect the environment
- to monitor, record and benchmark environmental performance on a regular basis.

Business Integrity

- to tolerate no form of and not to engage in any form of corruption or bribery, including any payment or other form of benefit conferred on any government official for the purpose of influencing decision making in violation of law
- to safeguard from disclosure IHG's confidential and proprietary information as well as its employee and customer privacy and personal information
- to avoid business activity that would conflict or interfere with the provision of products and services to IHG
- to accurately record and disclose information regarding business activities, structure, and financial situation and performance in accordance with applicable laws, regulations and industry practices.

Maltese

Dan il-Kodiċi tal-Kondotta għall-Bejjiegħa ta' IHG jstabilixxi r-rekwiżiti, il-prinċipji u l-prattiki li IHG adottat biex tippromwovi l-imġiba etika fuq il-post tax-xogħol, kundizzjonijiet tax-xogħol siguri fil-katina ta' provvista, trattament tal-persuni b'rispett u dinjità, u Prattiki ambjentalment responsabbli. Dawn huma l-istandards minimi li bihom huma mistennija joperaw il-bejjiegħa ta' IHG, u IHG tinkoraġġixxi lill-bejjiegħa biex imorru lil hinn mir-rekwiżiti stabbiliti hawn taht.

Għalhekk il-bejjiegħa jiddikjaraw:

Konformità mal-Liġijiet u r-Regolamenti

- li jkunu konformi mal-liġijiet tal-pajjiżi applikabbli li joperaw fihom kif ukoll il-liġijiet internazzjonali relatati mal-imġiba kummerċjali.

Xogħol u Drittijiet tal-Bniedem

- li jappoġġjaw il-protezzjoni tad-drittijiet tal-bniedem, b'mod partikulari dawk tal-impjegati tagħhom, il-partijiet ma' min jagħmlu n-negozju u l-komunitajiet fejn joperaw
- li jirrispettaw id-drittijiet tal-impjegati tagħhom għal-libertà volontarja ta' assoċjazzjoni skont il-liġi
- li jipprovdu ambjent tax-xogħol sigur u ħieles mill-periklu
- li ma jappoġġjawx xogħol forzat u obbligatorju jew l-isfruttament tat-tfal
- li jappoġġjaw l-eliminazzjoni tad-diskriminazzjoni u l-fastidju fuq ix-xogħol, u jippromwovu d-diversità fuq il-post tax-xogħol
- li jipprovdu lill-impjegati b'rimunerazzjoni u għodda biex ikabbru l-karrieri tagħhom, u li jikkunsidraw dejjem il-benesseri tagħhom.

Protezzjoni Ambjentali

- li jimplimentaw Prattiki ambjentali sodi fid-disinjjar, l-iżvilupp u l-operat tan-negozju tagħhom u li jipprovdu t-taħriġ u r-riżorsi meħtieġa biex dawn il-prattiki jġu implimentati
- li jinkoraġġixxu l-iżvilupp u l-integrazzjoni ta' teknoloġiji sostenibbli li jaħdmu biex inaqqsu l-użu tal-enerġija u l-ilma, u jerrġgħu jużaw u jirriċiklaw ir-riżorsi kkunsmati min-negozju tagħhom kull fejn dan ikun Prattiku
- li jimpenjaw lill-klijenti tagħhom, il-kollegi, l-imsieħba, il-fornituri u l-kuntratturi fl-isforzi tagħhom biex jiproteġu l-ambjent
- li jimmonitorjaw, jirreġistraw u jistandardizzaw il-prestazzjoni ambjentali fuq bażi regolari.

Integrità Kummerċjali

- li ma jittolleraw u ma jwettqu l-ebda forma ta' korruzzjoni jew tixħim, inkluż kwalunkwe flus jew forma oħra ta' benefiċċju mogħti lill-kwalunkwe uffiċjal tal-gvern għall-finijiet tal-influenzar tat-tehdid tad-deċiżjonijiet bi ksur tal-liġi
- li jissalvagwardjaw milli tiġi żvelata informazzjoni kunfidenzjali u rizerjata ta' IHG kif ukoll l-informazzjoni privata u personali tal-impjegati u l-klijenti tagħhom
- li jevitaw l-attività kummerċjali li tkun f'konflitt ma', jew tinterferixxi fil-provvista tal-prodotti u s-servizzi lil IHG
- li jirreġistraw bi preċiżjoni u jżvelaw l-informazzjoni rigward l-attivitàjiet kummerċjali, l-istruttura, u s-sitwazzjoni u l-prestazzjoni finanzjarja skont il-liġijiet applikabbli, ir-regolamenti u l-prattiki industrijali.

Supply Chain

- to use reasonable efforts to ensure that vendors, subcontractors and suppliers also operate in a manner consistent with the IHG Vendor Code of Conduct.
